- 5.3. The request fee payable by a requester, other than a personal requester, referred to in regulation 11(2) is R50,00.
- 5.4. The access fees payable by a requester referred to in regulation 11(3) are as follows:
 - 5.4.1. Fees are:
 - 5.4.1.1. For every photocopy of an A4-size page or part thereof R1,10
 - 5.4.1.2. For every printed copy of an A4-size page or part thereof held on a computer or in electronic or machine-readable form R0,75
 - 5.4.1.3. For a copy in a computer-readable form on:
 - 5.4.1.3.1. stiffy disc R7,50
 - 5.4.1.3.2. compact disc R70,00
 - 5.4.1.4. For a transcription of visual images:
 - 5.4.1.4.1. for an A4-sized page or part thereof R40,00
 - 5.4.1.4.2. For a copy of visual images R60,00
 - 5.4.1.5. For a transcription of an audio record:
 - 5.4.1.5.1. For an A4-size page or part thereof R20,00
 - 5.4.1.5.2. For a copy of an audio record R30,00
 - 5.4.1.6. To search for and prepare the record for disclosure, R30,00 for each hour or part of an hour reasonably required for such search and preparation.
 - 5.4.2. For purposes of section 54(2) of the Act, the following applies:
 - 5.4.2.1.1. Six hours as the hours to be exceeded before a deposit is payable; and
 - 5.4.2.1.2. one third of the access fee is payable as a deposit by the requester.
 - 5.4.3. The actual postage is payable when a copy of a record must be posted to a requester.
